

#### What Is SFDR?

The **Sustainable Finance Disclosure Regulation** (SFDR) is legislation reshaping investment funds. It mandates transparency and disclosure of sustainability factors.

An **SFDR Fund Positioning Strategy** is crucial for regulatory compliance, market differentiation, and meeting investor expectations. It serves as a roadmap communicating your fund's commitment to sustainability, risk management, and improved market access.

Compliance with SFDR Articles 8 or 9 also distinguishes your fund's commitment to sustainable finance. **Article 8** focuses on promoting environmental or social characteristics, whereas **Article 9** centres on funds with a sustainable investment objective. Aligning with these articles enhances transparency, builds trust, and meets evolving market expectations.






# Phase 1 Developing Your SFDR Strategy

This offers transparent and standardised information for regulatory compliance and informed decision-making by investors, presented to your legal team for review.

We create an internal **Procedure Guide**, outlining how to operationalise your fund's SFDR Strategy, with designated responsibilities and reporting requirements.

This end-to-end approach ensures SFDR compliance and equips your fund with robust internal processes and documentation.
