Data Requirements

To qualify for an Arc Performance Certificate that is valid for GRESB, assets must provide at least 3 of the following:

Energy: 12 consecutive months of energy use data; usually on-site combustion of liquid fuels and purchased electricity

Water: 12 consecutive months of whole project potable water use

Waste: 1 waste audit in a 12-month period providing information on waste generation and waste diversion

Transportation: 1 occupant survey providing information on commuting distance and travel mode

Human Experience: 1 occupant survey plus 1 sampling of indoor air quality in a 12-month period





Steps to Certification

1. Upload Data

Enter your building's performance data into the Arc platform.

2. Benchmark Performance

Arc assesses results against trusted sustainability benchmarks.

3. Generate Certificates

Receive digital certificates based on real-world performance.

4. Submit to GRESB

EVORA submits your certificates to GRESB for scoring.
