## The Challenge

The GRESB Infrastructure benchmark is becoming increasingly competitive, with the threshold for achieving a 5-star rating rising year on year.

Maintaining 5-star status is no longer a case of keeping performance steady, it demands continuous improvement, deeper data coverage and demonstrable progress across a broad set of sustainability indicators.

**Against this backdrop of rising expectations, SGI continues to rely on EVORA's expertise to refine their sustainability strategy and streamline their GRESB submissions.**





## Our Approach

EVORA has supported SGI with their GRESB Infrastructure submissions since 2021, focusing on closing gaps in sustainability performance and curating **accurate, compelling evidence** to meet GRESB's rising standards.

In 2024, EVORA conducted a comprehensive **Physical Climate Risk Assessment** to identify climate-related hazards across the portfolio, quantify their potential impacts and prioritise mitigation actions.

The insights generated not only fed directly into SGI's long-term resilience strategy but also strengthen this year's GRESB submissions by demonstrating a proactive approach to risk management and climate adaptation.





## Key Outcomes

EVORA's strategic support has contributed to a consistent and significant improvement in SGI's GRESB performance, reflected in their score progression:

The 2025 outcome places SGI **1st among its peers** in the “**Natural Resources Transportation Companies – Maintenance and Operation**” category, further strengthening their infrastructure sustainability performance.

Alongside this achievement, SGI has successfully **maintained a 5-star GRESB rating**, demonstrating sustained commitment to sustainability leadership rather than one-off performance gains.

These results highlight the value of EVORA's ongoing collaboration with SGI: strengthening both their internal sustainability performance and their external market reputation year on year.
