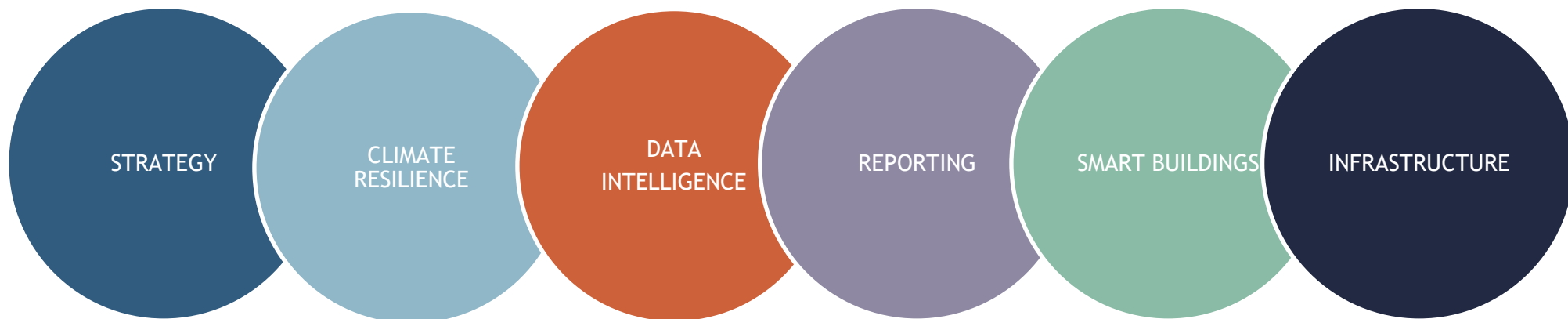

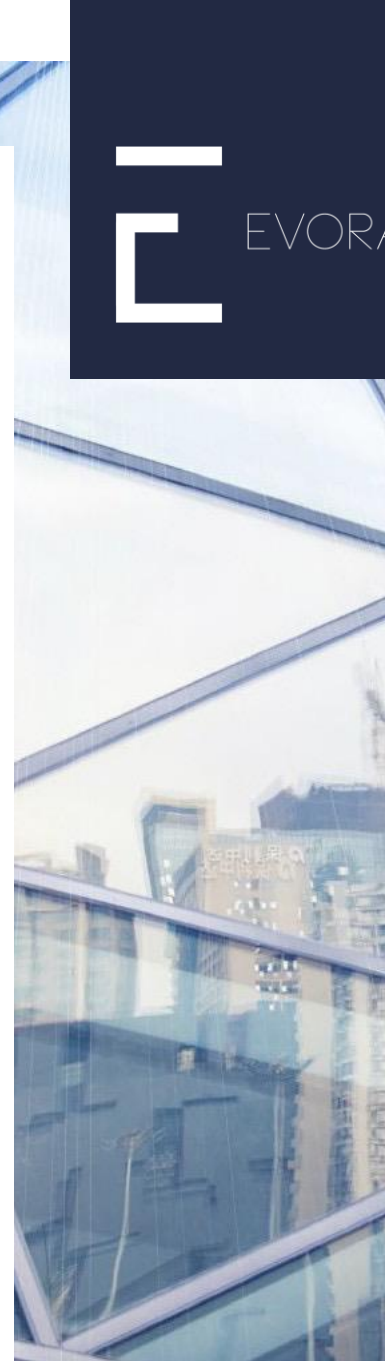



As part of our mission to drive positive change within the real estate industry, we are highly aware that one of the most effective ways to achieve this goal is for us to share our knowledge and passion.

1	<p><u>101</u> Sustainability for Real Estate</p>	<p>An introductory course aimed at anyone and everyone in the real estate industry. We will explore the key themes, how they impact buildings, and explain how to approach sustainability as well as practical tips on where to start the journey.</p>
2	<p><u>101</u> Sustainability for Investment Professionals</p>	<p>This course is aimed at those involved in the investment process within real estate. We will address key sustainability value drivers, where risks and opportunities exist and how to implement a strategy into an investment process.</p>
3	<p><u>202</u> Net Zero and how to get there</p>	<p>Many companies have declared their commitment to reaching Net Zero. But what does this really mean, and how can they get there? This session is a deep dive into the language, metrics of net zero strategy and will provide practical guides as to how to begin your own journey.</p>
4	<p><u>202</u> TCFD Reporting (Task Force on Climate Change Related Disclosure)</p>	<p>TCFD is currently voluntary but with its adoption by the UN PRI and other industry bodies, we soon expect it to become the necessary, then mandatory. This session will explain the key impacts of TCFD and how real estate investors will need to address this in their strategy and processes.</p>
5	<p><u>202</u> Legislation & the EU Taxonomy explained</p>	<p>The European Commission has explicitly stated its decarbonisation goals and produced a clear 'taxonomy' with which to report on climate impacts across all industries. In this session, we will explore the current and imminent legislation governing sustainability and the EU Taxonomy.</p>
